PARTICIPATION REQUIREMENT AGREEMENT

	I,, as the parent or legal guardian of
	(minor child) and in consideration of the opportunity to enroll my minor child as a participant
	in Dance With Heart, LLC, agree, on behalf of myself, my minor child, to the following
	Participation Requirements, as well as any other Participation Requirements that may be put in
	place from time to time by Dance With Heart, LLC and/or its authorized representatives.
	agree and understand that my minor child continued participation with Dance With Heart, LLC,
	requires compliance with all Participation Requirements and that my or my minor child's failure
	to comply may lead to immediate removal from Dance With Heart, LLC.
o I	Physical Requirements: I recognize that physical exertion and the possibility of physical injury
	could occur to my minor child due to the nature of participating in Dance With Heart, LLC. I
	attest and certify that my minor child is physically fit to participate safely, and I have not been
	advised otherwise by a health care professional. I agree to notify Dance With Heart, LLC
	immediately if my child is unable to participate in physical exertion safely, either with or
	without the recommendation of a health care professional.
(Classroom Conduct: I understand that my minor child is expected to follow the direction of his
	or her dance instructor and limit his or her movements in class to those that are being specifically
	instructed, in the way they are being instructed to perform. I understand that this requirement is
	for the safety of my minor child and any other participants. Failure to comply will lead to my
	child being removed from participation.
□ I	Harassment or Bullying is Not Tolerated. I understand and agree that Dance With Heart, LLC
	promotes an environment free of harassment and bullying. If me or my minor child participates
	in, or encourages harassment or bullying of others, they will be immediately removed from
	participation with Dance With Heart, LLC. If me or my child witnesses or experiences



harassment or bullying, we will report this behavior immediately to the Director of Dance With Heart, LLC or their instructor.

- □ **Dress Code**: I understand that my minor child is expected to wear proper attire for each class, including hair tied back according to the dress code form and no jewelry that may be distracting or hazardous. **Shoes**: Additionally, I agree to provide my minor child with shoes according to the dress code form in order to protect my minor child while performing and practicing.
- □ Arrival, Preparation, and Departure: I understand and agree that my minor child is expected to arrive at the studio immediately prior to the start of class fully ready to participate. An early arrival is recommended, up to 15 minutes prior to the start of class, if needed to allow time to use the bathroom, dress, remove jewelry, and neatly put hair back. All students MUST be picked up within 10 minutes of the end of class. NO parents/caregivers/siblings in the studio while class is in session. Students are expected to arrive and depart the studio in street clothes, or with street clothes covering their dance attire.
- □ Class Attendance and Makeup Classes: I understand my minor child is expected to attend all classes on a regular and consistent basis. Dance With Heart, LLC reserves the right to offer or schedule makeup classes.
- □ **Studio Etiquette**: My minor child and I are responsible for all personal belongings brought into the studio. Dance With Heart, LLC recommends we do not bring valuables into the studio or waiting area and does not offer secure space to store personal property. Dance With Heart, LLC is not responsible for lost, stolen, or misplaced property.
- □ **Photography and Videotaping**: NO photography or videotaping allowed by me, my minor child, or anyone else who has not been specifically authorized by Dance With Heart, LLC. This prohibition includes all practices or performances. I understand that photographs, recordings, taping, or filming of participants by any Dance With Heart LLC teachers, independent



contractors or members of the press become the property of Dance With Heart LLC and may be used for future publicity. By signing each of the undersigned participants and/or participant's parents involved with Dance With Heart LLC expressly adopts and agrees to be bound by this waiver and release agreement.

- □ Waiting Area: The waiting area is expected to be quiet and respectful while class is in session. I understand that anyone not complying with this rule may be immediately removed from the waiting area or studio.
- □ **Use of Equipment**: I understand and agree that my minor child and I will use all studio equipment as specifically directed and ONLY with express permission by Dance With Heart, LLC.
- □ **Food and Drink**: I and my minor child understand and agree that gum, food, or drinks other than water are NOT permitted in the studio.
- □ Late Fee Policy: I understand and agree that a \$30.00 late fee will be assessed *per student* for payments not received within a two-week grace period from payment due date. I further understand and agree that valid credit card information is required to be on file at the time of registration as 2 late payments (either consecutively or **non**consecutively), resulting in the account not being brought current, will result in automatic enrollment in auto-pay. A fee of \$30.00 will be assessed for any/all returned checks on a per check basis. If my account is not brought current each month, my child will be removed from their classes. In the case of financial hardship, i.e., job loss or other significant life events, it is my responsibility to immediately contact the studio Director for possible special payment arrangements or considerations. Any/all arrangements or special considerations are at the sole discretion of the studio Director.



Semester Withdrawal Policy: I understand and agree that Dance With Heart, LLC operates on a
two semester dance season — September through December & January through June.
Withdrawals are allowed without penalty up until October 15th for the Holiday Show and March
15th for the End of Year Recital. If withdrawal occurs after the grace period, a \$100 withdrawal
fee per dancer will be charged to my account. Additionally, a withdrawal slip MUST be
completed and submitted to my studio to cease monthly tuition fees.

□ I understand and agree that this Agreement contains the entire understanding between Dance With Heart Studios, LLC, my minor child, and me concerning these matters. No waiver, modification, or amendment of any of the terms of this Participant Requirement Agreement shall be effective unless made in writing and signed by the Director of Dance With Heart, LLC.
